



Sony Creative Software Education/Non-profit OFF-Campus Reseller Authorization

The reseller identified below applies for authorization to resell Sony Creative Software products and services ("Sony Creative Software Products") and certifies that it will comply with the following conditions:

1. We agree to only sell Sony Creative Software products within the defined territory. Sony Creative Software defines the territory as the fifty United States of America and its territories, Canada and Latin America. The named resellers must sell within this territory.
2. We agree to resell Sony Creative Software Products to approved Educational and Non-profit entities only, defined as follows:
 - a. Acceptable Institutions and Organizations: Elementary Schools, Middle Schools, Jr. High Schools, High Schools, Jr. Colleges, Community Colleges, Private and State Colleges, Universities, Accredited Vocational Schools (i.e. trade schools providing certificates for specific specialties, such as Head Business School.) Acceptable affiliates of the above including: Museums, Hospitals, Labs (i.e. Stanford Hospital); Non-profit organizations as defined in Section 501 (c) (3) of the U.S. Internal Revenue Code of 1986, as amended.
 - b. Acceptable Individuals: Full-time and part-time students enrolled in grades K-12 and higher education (at accredited public or private primary schools, secondary schools, or higher education institutions), full and part-time faculty or staff members (employed by accredited K-12 or higher education institutions).
3. We agree to require appropriate identification before selling to end-users, and to verify that the identification is current and legitimate, to the best of our knowledge. An institution's purchase order or an individual's current school, college or university identification card shall be considered valid school identification. A copy of an organization's Section 501 (c) (3) determination from the Internal Revenue Service shall suffice to establish non-profit status.
4. We agree to retain reasonable records, and agree to make such records available for audit upon reasonable notice, showing the Sony Creative Software Product sold, the institution or individual's name, address and phone number (or a copy of the school's purchase order or copy of the student, faculty or staff identification or IRS determination, if applicable) for every Sony Creative Software Product sold.
5. We agree that when Sony Creative Software products are advertised in print, catalogues, web sites or through any other visual media, the reseller will clearly indicate that product is an academic product and will only sell to academic authorized end-users.
6. We agree, if we have sold Sony Creative Software Products other than as set forth in this Certification, that our authorization to sell Sony Creative Software Products may be terminated.
7. The undersigned represents that he or she has the authority on behalf of reseller to make this certification and to bind reseller to the terms of it.
